SUBJECT: RECOMMENDATION TO AMEND THE LOS ANGELES MUNICIPAL CODE TO

PROHIBIT RODEO EVENTS IN THE CITY OF LOS ANGELES

BOARD ACTION RECOMMENDED:

- 1. **RECOMMEND** to the Mayor and City Council that the Los Angeles Municipal Code (LAMC) be amended to prohibit rodeo events in the City of Los Angeles; and
- AUTHORIZE staff to transmit the recommendation to the Mayor and City Council and request the
 City Council to request the City Attorney to draft an ordinance amending the LAMC to reflect the
 recommended changes.

BACKGROUND:

Each year the City of Los Angeles host rodeo exhibitions or contest in which participants perform various activities involving animals, including riding broncos, roping calves and/or wresting steers. These events can be harmful to the health and well-being of the animals that are used in the rodeo competitions and shows, at times resulting in injuries such as sprains and broken limbs.

The City Council is considering the adoption of an ordinance that would amend the LAMC to prohibit the use of harmful implements at rodeos in the City (CF #20-1575). While this is a commendable proposal, the Department recommends that the City go further and completely prohibit rodeos in the City to protect the animals involved in these events. The Board should weigh in before the City Council takes final action on the proposed ordinance.

SUMMARY:

In keeping with the City's practices regarding the welfare and well-being of animals, the Department is recommending the prohibition of rodeo events in the City of Los Angeles. These events should include bull riding, bronc riding, calf roping, steer wrestling, team roping, tie-down roping, and similar events and activities.

Other local cities including San Francisco, Pasadena, Irvine and Chino Hills, California have already instituted regulations to restrict or prohibit rodeos taking place in their cities.

FISCAL IMPACT:

The prohibition of rodeo events in the City of Los Angeles may result in some impacts to future revenues to the Department from the collection of permit fees for rodeos.
